Encouraging Words to Small School Financial Aid Administrators

Grants, Work-study, Loans, Scholarships; Clock or Credit hours; Header, Trailer; Verification, PJ, SAP, R2T4, Enrollment Rosters; Net Price Calculators; State Aid, Federal Aid, Institutional Aid; Cohort Default Rates; VA Benefits; State Reports & Surveys, IPED's; End of the year closeouts; Auditors; COD, FAA Access, NSLDS......OH, MY! These are among the terms that "hit" me when I started into the financial aid world.

If someone had told me that I would be working in financial aid - even 5 years ago, I would not have believed him or her! You see, I blindly stepped into financial aid without any foreknowledge of it. However, that happens sometimes, when you are involved in a small school setting.



My start in financial aid was in the fall of 2018, when I was hired to help out our Financial Aid Director – part-time. That part-time turned into full-time just one year later, when our Director moved onto a different ministry.

However, because of Covid-19, most of those webinars and workshops have been virtual.

Get involved as much as you can – we all have a lot to do. It will be worth the investment for you and your students!
